SUMMARY OF THE FINDINGS (IN 500 WORDS)

In Minor Research Project we have considered the concept of Human Development its importance, Index of human development, report of united state & District development programme, There is calculation of the index of Income, Education, Health of Maharashtra and Buldana. Even there is comparative study by calculating Index of human development. There is also detailed analysis of various scheme, backlog and human development index and co-relation between them. Many hypothesis are represented and verified in this respect. All conclusions are made by this study. Important conclusions are as following with some remedies.

1) Human Development Index of Studied districts is lower than the average of Maharashtra State 2) Decline in the ratio of sex. 3) Low literacy rate among women 4) Growing participation of women 5) Failure of Family planning 6) Lack of Coordination among the Departments 7) Lack of medical facilities 8) Need of growth in qualitative works of ICDS 9) Alertness of Hygiene and 100% use of toilets. 10) Regularly supply of potable-water. 11) The Need of growth of the Index of Longevity 12) Predominancy of Illiteracy 13) The enrichment in the ‘Sarva - Shiksha - Abhiyan’ and the index of school education development, is Advantageous / promising 14) The Necessity of special planing and strategy for secondary schools and colleges. 15) Studied Districts have more percentage of dropouts regarding education. 16) The need of Increase in the index of Literacy in studied Districts 17) The contribution of the income of primary sector to the income of district. 18) The Meagerness of irrigation. 19) Miserable State of Employment 20) The remarkable contribution of “Rojgar Hami Yojna” to employment. 21) The growing rate of the families of below -poverty-line, is grave. 22) The sanctioned outlay and provisioned fund neither budgted nor utilized. 23) Efforts are not made to increase the human resource through the schemes. 24) Because of Backlog, the studied districts have the lower index of human development. 25) The per-capita Index of studied the Districts is very much lower.

If above conclusions are implemented, the disparity in health, education, and economy, can be reduced and it will certainly cause to the growth in human development index.
